Permits issued at Kenmore City Hall must be paid for with cash or check only; credit card payments are accepted only for applications received online via mybuildingpermit.com. Fees are based on the fee resolution in effect at the time of application. ▪ Streams, wetlands, landslide hazard, bald eagle and heron zones; <ul style="list-style-type: none"> ➢ Hazard trees may be removed if deemed hazardous by an ISA Certified or equivalent arborist. ➢ A hazard tree report must be submitted for each tree. ➢ Replacement trees are required for trees removed in critical areas and/or buffers. ➢ Removal in Bald Eagle and Heron habitat zones must be approved by the State of Washington Department of Fish and Wildlife. Replacement may be required. ▪ Any tree that is an imminent hazard to life and/or property (fixed target) may be removed immediately without first seeking approval. For trees that would have required a permit, a post-mortem report must be submitted to the City defining the hazard with supporting documentation, such as an ISA tree hazard report and photographs within seven business days. | | |
